HEMPSANA RECEIVES SECOND HEALTH CANADA LICENSE

TORONTO, ONTARIO | GODERICH ONTARIO – May 19, 2020– Hempsana (“**Hempsana**” or the “**Company**”) is pleased to announce that its Goderich Facility received the Standard Processing License from Health Canada, issued under the Cannabis Regulations.

Hempsana provides an update on the progress of the Goderich Facility, which was issued the Standard Processing License on May 15 2020 by Health Canada in accordance with the Cannabis Act and Cannabis Regulations, providing the Company the ability to possess, produce and sell cannabis in the facilities’ indoor production areas.

This License receipt supplements the Company’s current approval to extract Cannabidiol (“CBD”) in an agricultural country in the EU, as well as Company’s Industrial Hemp Cultivation License issued by Health Canada in August 2019.

The Company’s Goderich Facility, which completed development in Q4 2019, is a 10,000 square foot ISO-8 clean room and EU-GMP compliant controlled facility, that will be the Company’s primary site for extraction of cannabis derivatives and end-product manufacturing.

“We are very excited about being granted the License, and we are appreciative of Health Canada, as they were undoubtedly stretched on resources with the COVID-19 situation. Through the challenges of the on-going pandemic, the team was able to successfully execute on the Company’s build-out plan, and . The diligent and hard work by the entire team now provides Hempsana to drive forward on its focussed revenue generating activities,” says Sohil Mana, CEO and Chairman of the Company.
